### PROFESSIONAL ACTIVITIES

**Carla Abodalo** (Sociology) provided commentary to the Reading Eagle in an article entitled "A Recipe for Crime," which appeared in the wake of the recent shooting death of a Reading Police Officer. She was asked to identify specific factors that contribute to Reading's crime problems.

**Mary Jane Androne** (English) attended the African Literature Association conference in Accra, Ghana in May where she presented a paper, "Male Characters in Ama Ata Aidoo's Changes—Nervous Masculinities."

**Jon Bekken** (Communications/English) appeared on a panel on the history of jailing journalists as part of the annual convention of the Association for Education in Journalism & Mass Communication in August, discussing his research of IWW journalists jailed during the War. Jon's coauthored history of the Industrial Workers of the World is now in press, and will be released later this month. He submitted encyclopedia entries on syndicalism and the American labor press and approved proofs for an entry on newsboy strikes. Articles on the Chicago immigrant workers press and the IWW centenary are now in press with Illinois History Teacher and Perspectives on Work.

**Tom Brogan** (Political Science) attended the American Political Science Association meeting in Philadelphia on September 1 and 2 to prepare for the regional and state association meetings in 2006 and 2007.

On August 3-6, **Teresa Gilliams** (English) participated in a seminar at Transylvania University in Lexington, KY entitled "Twenty-first Century Liberal Education: A Contested Concept."

**Marsha Green** (Psychology) gave a talk on Acoustic Impacts on Marine Mammals at the College of the Bahamas in May. In June, she spoke on behalf of the International Ocean Noise Coalition at the seventh meeting on Oceans and the Law of the Sea at the United Nations and attended the annual meeting of the International Whaling Commission. Marsha was also a part of an international group doing research on the impact of sonar on marine mammals in July during the month long RIMPAC naval exercises conducted by the U. S. and six other nations.

**Richard Hamwi** (Art) had two watercolor and ink collages titled "Valley" and "Illumination" accepted for inclusion in the "2006 Hoyt Mid-Atlantic Juried Art Exhibition" to be held at the Hoyt Institute of Fine Arts in New Castle, Pennsylvania, October 1<sup>st</sup> to November 10<sup>th</sup>, 2006. The juror for the exhibition was Faith Ringgold, who is internationally known for her artwork. **Julia Heberle** (Psychology) was selected from more than 100 applicants to be one of 10 developmental psychologists to participate in pilot testing of Child Development Laboratory curriculum materials in Santa Monica CA, as part of an NSF grant recipient's outreach/dissemination. As a result of the two days of training received in June, Julia is currently implementing some of the materials with her Child Development Honors Module students, and plans further expansion next semester for a new senior seminar

In May, **Jeffrey Lentz**, Artist in Residence, received critical acclaim for his debut at the Kennedy Center in Washington DC as part of a fully staged production of Benjamin Britten's opera, *Turn of the Screw*, under the baton of the New York Philharmonic's Music Director, Lorin Maazel. In June, Jeffrey portrayed the same role, Peter Quint, in another production of Britten's *Turn of the Screw* during his South American debut at the Teatro Municipal in Santiago, Chile. This production, under the baton of maestro Jan Lathem-Koenig and the direction of Marcelo Lombardero, is slated for co-production at the Teatro Colon in Buenos Aires some time next year.

An essay of **Lawrence Morris** (English), "Saints in Society: Recent Approaches to Early English Hagiography," appeared in *Peer English 1* (2006), which was published in July. He also participated in the 2006 International Medieval Congress in Leeds, UK.

On August 18, **Susan Seidenstricker** (English) presented at The Pennsylvania Teacher Educators' Forum in Harrisburg. With two colleagues from the Education Department of East Stroudsburg University, Susan led a session entitled *Developing Teachers' Voice in the Professional Development School*. Senior Lisa Staub also shared results of her collaborative ACRE study, in which she and Susan interviewed elementary teachers in Albright's Professional Development School, 13<sup>th</sup> & Union Elementary. A study initiated to learn more about the urban teaching/learning environment in Reading School District, the project evolved into ongoing opportunities for reflection and study of best instructional practice in the urban setting. Susan and Lisa recently provided a report to Reading School District administration with a focus on the teachers' perspective on the challenges and rewards of urban teaching.

**Claudia Strauss** (English and Communication) gave the keynote address at the Syracuse University Hospital's Annual Conference on Alzheimer's in June and ran a workshop on "How to Apply Communication Techniques When Dealing with Alzheimer's Disease." Claudia also conducted a seminar for the community-at-large in Staten Island, NY to promote awareness and help educate people on the topic of Alzheimer's. This event was sponsored by Sunrise Senior Living in July. The French edition of her book, *Talking to Depression*, has been released by Dunod-InterEdition under the title *Vivre & Communiquer Avec Une Personne Dépressive*. A Spanish edition of *Talking to Eating Disorders*, co-authored with Jeanne Albronda Heaton, will be released by Ediciones Mensajero in 2007.

### **From Kristel Kemmerer, Acting Dean of Students:**

1. Jake's Java. Student Activities will be sponsoring a Faculty/Student Java-Fest between 9 and 11 am, September 18 – 22, in the Campus Center Main Lounge. Faculty will be receiving tokens to redeem their *free coffee* and *sweet treat* shortly. Students will be receiving free coffee and sweet treat passes in their mailboxes. We encourage all faculty to let students know when they will be redeeming their coffee tokens so they can meet and share ideas, have some informal conversation, and show our students what it means to be a part of our Albright family!
2. IQWeb. I am also very pleased to report that we are still on target with our online registration implementation schedule. As you know, this fall we have a healthy crop of Albright Pioneers who will be piloting online course registration with their advisees. Their training will be on October 2 and October 5. (Remember: A sense of humor was one of the prerequisites.)

In spring 2007, ALL course registration will be done online. There are two things that our faculty can do, starting now, to make the online course registration go smoothly this spring.

  - Please make sure your advisee list is current and complete. An important part of successful online course registration is the accuracy of adviser/advisee information. If you have been assisting a student with course registration who is not an 'official' advisee, the system won't allow you to register that student for classes.
  - Take note of any holds that have been placed on the student's record. A hold prevents a student from registering for classes; holds can be imposed for academic, financial, or behavioral reasons. It appears on the record as a stop sign. When you or the student clicks on the stop sign, a prompt appears that indicates what hold has been placed. It is the student's responsibility to go to the appropriate office and take action to have the hold removed. Advisors can help by pointing to the student to the appropriate office before (way before) the student needs to register for courses. That

will really help alleviate frustration for both the student and the office. The most common holds and appropriate offices are

- Academic Dismissal hold – Registrar
- Academic Probation hold – Registrar
- Account Balance Due hold – Business Office
- Behavioral Dismissal or Suspension hold – Student Affairs Office

3. Travel Forms. The forms for off-campus travel have been revised and are posted online under Online Forms – Academic. Hard copies are also with each building secretary. The forms are in three folders: off-campus travel for academic field trips, off-campus travel for organizations, and general off-campus travel. Please make sure the forms in the folder are completed and approved on time.

Special reminder that last spring the faculty approved an Excused Absence Policy that includes notification for field trips. That policy is online under Faculty Resources – Excused Absence Policy.

4. Student Alert Form. The Student Alert form was also revised to include non-academic student concerns. The form is linked to the College intranet and can be submitted electronically to our Office of Enrollment Management. From there, the appropriate office(s) is notified so the student receives interventive assistance for the area of concern.
5. Academic Advising. Thanks to everyone who participated in our academic advising sessions during Sneak Peek and orientation. The feedback I received from faculty and students was very positive. In fact, of the students who attended Sneak Peek and completed a satisfaction survey, 98% rated the Academic Advising session as 'good', 'very good', or 'excellent'.

Have you ever wondered what happened to the Sneak Peek surveys that faculty filled out in summer 2005 and summer 2006? Those results are posted on the College intranet – click on Faculty Sneak Peek Survey Results. You will see that we took your suggestions from 2005 very seriously and were able to remedy most of your concerns for summer 2006. We plan to use your suggestions from this summer, too, to make 2007 even better yet!

Finally, if you did not return your advising information sheets to the Academic Affairs, please do so. These sheets have proven to be very helpful when we need to get in touch with a student who may not use college e-mail or room phone.

6. Community Standards Hearing Board. Thank you to the faculty accepted their appointments to serve on the Community Standards Hearing Board or as a Community Standards advocate. 7. Waivers. Faculty are reminded that FERPA prevents us from discussing students' academic, behavioral and financial records unless an waiver has been signed by the student. This includes discussion with parents. In an effort to alleviate confusion and frustration with the myriad of waivers for releasing student records, we consolidated the old forms into one neat, inclusive page. For advisors, this means that the box "Academic Records and Academic Information" needs to be checked before you can discuss academic information with anyone except the student and relevant College personnel. The waivers are available from the Registrar, Student Affairs Office, and Business Office.

The only office that still has their own waiver is the Health and Counseling Centers. There are HIPA regulations there that are bigger than us.

8. Add/Drop. According to the Registrar and the students I talked to, the one-week period add/drop period seemed to have worked well. What are the thoughts of the faculty? What can we do to make it more effective for you?
